Either replace the battery ASAP or obtain a new thermometer for daily use. Of note, this facility does not record food temperatures on a log sheet for food temperature control compliance verification. It is recommended that such a program be implemented.

Violation: IMPROPER MAINTENANCE OF FACILITY OR EQUIPMENT [HSC 114161-114182 & 114257]

Description/Corrective Action: Top set base board along the south wall and food prep areas has been removed and/or detached due to disrepair. Repair or replace this within the next six months.
