Violation: IMPROPER CLEANING OF UTENSILS AND EQUIPMENT [HSC 114095-114099.5 & 114101-114119]

Description/Corrective Action: Food debris accumulation was noted on the door handles of the produce storing reach-in refrigerator. Have the grab handles cleaned.

Violation: LACK OF OR IMPROPER USE OF THERMOMETERS [HSC 114157-114159]

Description/Corrective Action: The facility operator was utilizing an old stem thermometer for food temperature monitoring rather than a digital probe thermometer. A digital probe thermometer was provided by the inspector during the inspection.

Violation: IMPROPER MAINTENANCE OF HANDWASH FACILITIES [HSC 113953 - 113593.2]

Description/Corrective Action: Refer to hot water supply violation in both the men's and women's restrooms.

Violation: IMPROPER MAINTENANCE OF FACILITY OR EQUIPMENT [HSC 114161-114182 & 114257]

Description/Corrective Action: Hot water supply to the bar 3-compartment sink did not get hot after allowing to run for on extensive time period. The facility operator reported it was tied in with the restroom hot water supply plumbing which was also not providing hot water. Repair this ASAP prior to the re-inspection in the next 3 days.

Violation: RESTROOM FACILITIES NOT MAINTAINED [HSC 114250 & 114276]

Description/Corrective Action: Hot water supply to both the men's and women's restrooms was not functioning. Water would flow but would not get hot.

General Comments:

All hot and cold food temperatures monitored today met State Food Code requirements. Correct the hot water plumbing violation by no later than Friday morning.
