Description/Corrective Action: Observed cooking cart (half flat grill and half steam table) heated with propane for outdoor preparation and service. The law only allows cooking (grilling) outside. Use of the steam table outside is not permitted. Discontinue use of the left side (steam table and cutting board) immediately and move product indoors for hot holding and service.

Description/Corrective Action: Unlabeled, bagged tortillas were noted in the self service customer area. If these are not for sale then they must be stored in an area not accessible by the public.
