Elections Code 10516(a): Notwithstanding any other provision of law, in any district or agency election, if a declaration of candidacy for an incumbent elective officer of a district is not filed by 5pm on the 88th day before the general district election, any person other than the person who was the incumbent on the 88th day shall have until 5pm on the 83rd day before the election to file a declaration of candidacy for the elective office.

As of 5:00pm August 6, 2010 the nomination period is closed for all incumbents that have not filed. Nominations for offices not shown as **CLOSED are open to any qualified candidate until 5:00pm, August 11, 2010, except incumbents who failed to file by the deadline.**
