WHEREAS, on December 19, 2012, the Oversight Board for the Successor Agency to the former Kings County Redevelopment Agency met and convened a public comment session on the Report; and

WHEREAS, the Oversight Board has considered comments from the public and the County Department of Finance; and

WHEREAS, the Oversight Board held a noticed public meeting on January 9, 2013, to ratify the transmittal to the State and County Departments of Finance the

determination of the amount of cash and cash equivalents that are available for disbursement to taxing entities per the Report.
